



Limited 15 Year (Product Only) Warranty

polarstone™ quartz surface warrants to the owner of the original installation of polarstone™ quartz surface (the product), that it shall be free from materials defects for a period of fifteen (15) years from date of commencement of installation.

During the first 15 years after the date of initial installation, the sole responsibility and liability of polarstone™ quartz surface shall be to repair or replace, at their option, if the product fails due to a manufacturing defect.

This warranty applies to polarstone™ quartz surface products installed after May 1, 2016. Installations prior to May 1, 2016 may be covered under a previous warranty. Contact polarstone™ quartz surface for details.

Terms and Conditions:

- The 15 year limited warranty applies to polarstone™ quartz surface materials only.
- The Product must be fabricated and installed by a qualified and trained fabricator and installer.
- The Product should be used and properly maintained in accordance with instructions provided by polarstone™ quartz surface in its polarstone™ quartz surface Product Care and Maintenance Guide.
- This warranty applies to polarstone™ quartz surface that have been permanently installed in an interior application and have not been moved from their original location.
- In no event shall polarstone™ quartz surface be liable for special, indirect, incidental, punitive, consequential, or any similar damages whether or not caused by or resulting from the negligence of polarstone™ quartz surface even if they have been advised of the possibility of such damages.
- polarstone™ quartz surface shall make its best effort to repair or replace with the best possible color match to the original material as possible. polarstone™ quartz surface cannot guarantee that the repair or replacement will be an exact color match to the original due to the natural minerals and ingredients used in the manufacture of polarstone™ quartz surface
- The owner must give prompt notice of any alleged defects discovered after exercising due diligence, and reasonably cooperate with the authorized service agent for polarstone™ quartz surface and provide access to the installation site to obtain service under this limited warranty.
- This warranty is applicable only to the original purchaser and only when all final payments have been made on the product.
- This warranty is non-transferable. Any associated repair or replacement cost other than the product will be the original purchaser's responsibility.
